"I am honored for the opportunity and committed to furthering the success of our organization for our individuals, their families and all of our team members," says Amy. Her first goal as president and CEO will be to reopen the day programs after COVID-19 closures

and move forward with the Community Settings Rule by providing individuals with opportunities to access their communities.

Amy brings more than 20 years of experience, the majority with Unified. She most recently served as chief operating officer and has also held positions as director of operations in Western Maryland and community services director, residential coordinator and recreational therapist in Frederick. During her tenure, she has prioritized fostering relationships between employees, so they work across zip codes to support each other. This teamwork has been invaluable during the pandemic.

"Amy has demonstrated over the years her leadership skills and her dedication to the individuals and families we support," says Unified Board Chair Ellen Milles. "I am excited to see how she will continue to grow our organization."

Among her many accomplishments, Amy believes her greatest contribution has been the creation of a disabilities awareness training program, where new employees experience receiving supports. "Employees learn firsthand how their actions impact the individuals we support," Amy explains.

She is also proud to have implemented technology across the organization. Amy says, "Unified was one of the first agencies in Maryland to have an electronic charting and communication system for staff that included medication administration. The increased accountability helped reduce errors and instantly allowed everyone to see in real time what was happening in our residential homes."

Former President and CEO Diane Coughlin says, "It has been a pleasure working alongside Amy during my 14 years at Unified, and I am thrilled to have been able to turn the reins over to her. I know she will take the organization to the next level and look forward to watching Unified thrive under her leadership."

#### NEW SERVICE FOCUS AT HAGERSTOWN CENTER

In our ongoing commitment to provide individuals with opportunities to access their communities, our Hagerstown Center is focusing on Community Development Services and no longer offering a facility-based day program. As COVID-19 restrictions relax, instead of participating in planned programming at the center, individuals will be out in their communities – choosing how and where to spend their time. The services will be tailored to each individual's interests. Some will be learning new job skills, and others will have paid employment or be volunteering. Many more will be out in their communities doing the same things we all enjoy such as shopping, going out to eat and visiting with friends.

"We are moving away from brick-and-mortar day programs and moving toward more community-based services, customized to the needs and preferences of the individuals we support," says Unified President and CEO Amy Kreitz. "These services will enable individuals to structure their days doing the things they want to do."

## DIANE COUGHLIN

Diane Coughlin arrived at Unified 14 years ago with a passion for improving the lives of individuals with disabilities. Before coming to Unified, she served under Governor William Donald Schaefer as director of the Governor's Office for Individuals with Disabilities and then worked at the Department of Health as the director of the Developmental Disabilities Administration.

When she retired from Unified at the end of May, she left a legacy that will shape the organization for years to come. She created an organization that is financially secure and will survive well into the future. When asked about her greatest achievements, she was quick to respond, "I cannot say enough about our talented staff and management team. They made me look good and helped me achieve so many of Unified's accomplishments during my tenure."

"Diane's compassionate dedication to the men and women of Unified has allowed our agency to provide exemplary services and programs. Her strategic leadership and ability to motivate others has led Unified to become the provider of choice in the disabilities community," says Amy Kreitz, president and CEO of Unified.

Diane is especially proud of changes in the residential program, firmly believing that the homes "belong" to the people who live in them and not to the agency or its staff. During her tenure, numerous older homes were sold and replaced with newer, nicer homes that are fully accessible, warm and inviting.

One of Diane's major projects was the rebranding of the organization after it left national United Cerebral Palsy and became Unified Community Connections. This decision reflected the fact that the organization served more than just people with cerebral palsy, and it made economic sense by eliminating affiliation expenses and other barriers to expanding services.

"I have worked with Diane for more than 10 years as a board member. Over the past few years as board chair, I worked closely with her and saw her exemplary leadership and dedication to Unified. She will be greatly missed, and I wish her well in retirement," says Ellen Milles, Unified board chair.

Diane has seen many changes in the disability community, especially the trend to move away from congregate and isolating facilities. To this end, she grew volunteer, educational and employment opportunities for individuals at Unified and increased their experiences from trips to the beach, movies, baseball games and museums to Disney World and cruises.



Integrating individuals into the community requires transportation, and through MTA grants, Unified was able to purchase 18 accessible vans. This allowed the agency to achieve the goal of having a vehicle at every residential home, paving the way for spontaneous trips to the movies and restaurants as well as planned vacations and outings.

Unified's fundraisers have grown over the years with very successful Hoodstock events and golf tournaments, enabling Unified to provide added supports for the men and women in the agency.

"I am especially proud that we keep our overhead below 10 percent, allowing funds raised to directly benefit the individuals," says Diane.

Diane also fulfilled one of her major goals to strengthen quality assurance and risk management throughout the organization. She also instituted staff training for disability awareness and created a mentorship program for direct care staff to enhance retention of this critical part of the workforce.

"I was on the search committee which named Diane CEO. Over the years, Diane has proved to be a superlative leader, possessing great passion for Unified while simultaneously gaining the respect and admiration of all who have been fortunate enough to interact with her," says Unified board member Howard Kurman.

In retirement, Diane looks forward to enjoying time with her husband Dave and their six grandchildren and travelling. She is also an avid hockey fan and plans to enjoy many Washington Capitals games.
